Who We Are

Freshwater Land Trust (FLT) conserves, connects, and cares for environmentally significant land and water in Central Alabama, creating dynamic green spaces for future generations. Nationally accredited by the Land Trust Accreditation Commission, we meet national standards of excellence, uphold the public trust, and ensure that conservation efforts are permanent.

What We Do

FLT owns and actively manages over 10,000 acres of land, making us one of the largest owners of private nature preserves in Alabama. Alongside our many partners, we have helped protect more than 11,000 acres throughout Central Alabama, including the 1,108-acre Red Mountain Park and the 700-acre Turkey Creek Nature Preserve. We work in Bibb, Blount, Choctaw, Coosa, Dallas, Etowah, Jefferson, Shelby, St. Clair, Tuscaloosa, and Walker counties and are proud to partner with governments, corporations, landowners, and community groups to protect our natural environment and increase public outdoor recreational opportunities.

In 2022, Jody Thrasher joined a growing number of landowners who have looked to Freshwater Land Trust to achieve their conservation goals. Thrasher's 1,128 acres in Coosa county includes a portion of Hatchet Creek, home to nine federally protected mussel species, as well as habitat for longleaf pine. The placement of Thrasher's property in a conservation easement will accomplish the meaningful conservation of its habitat and species.

How Can You Conserve Your Land?

Conservation Easements

A conservation easement is a legal agreement with FLT that limits the uses of your land to protect its conservation value. You maintain ownership while we monitor your property to ensure the land is preserved.

Benefits of Conservation Easements

- Conservation easements allow you to continue using your land and keep your property in your family. Although you release some rights, the land is still yours.
- Conservation easements are forever. If you decide to pass your land down within your family or sell it to another private owner, the rights established in the easement remain intact.
- Conservation easements are flexible. We'll work with you to establish your exact conservation goals, including protection from development, preserving wildlife habitats, or creating public access. These rights can apply to all or a portion of your property.
